## ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF CENTRAL STEEL SERVICE, INC.

- 1. The name of the corporation is Central Steel Service, Inc.
- 2. The Articles of Incorporation of said corporation are hereby amended by changing Article V thereof to read as follows:

#### ARTICLE V

### CAPITAL STOCK

The aggregate number of shares of capital stock which the corporation henceforth shall be authorized to issue and have outstanding shall be 10,526 shares of common stock, all of the same class, of the par value of \$1.00 per share, being a total authorized capital stock of \$10,526.

- 3. Said amendment was duly adopted by the unanimous vote of the directors and stockholders, by written consent without a meeting on November 13, 1984, as permitted by Section 10-2A-56 and Section 10-2A-66.
- 4. The number of shares of capital stock of the corporation outstanding at the time of such adoption was 10,000 shares of common stock, all of the same class.
- 5. The number of shares voted for said amendment was 10,000 and the number voted against was zero.
