MORTGAGE

KNOW ALL MEN BY THESE PRESENTS:

That, Whereas,

(hereinafter called "Mortgagors", whether one or more) are justly indebted to

collected, to be credited on said indebtedness, less cost of collecting same; amounts so expended by said Mortgagee for taxes, assessments or insurance, shall become a debt of said Mortgagee or assigns, additional to the debt hereby specifically secured, and shall be covered by this Mortgage, and bear interest from date of payment by said Mortgagee, or assigns, and be at once due and payable.
