

PETITION OF ALABAMA POWER COMPANY TO THE COUNTY COMMISSION OF SHELBY COUNTY, ALABAMA, FOR DESIGNATION PURSUANT TO THE PROVISIONS OF ACT NO. 604, ADOPTED BY THE LEGISLATURE OF THE STATE OF ALABAMA, ON MAY 1, 1978, OF LAND LOCATED IN SHELBY COUNTY, ALABAMA, AS AN INDUSTRIAL PARK

1. Alabama Power Company requests the County Commission of Shelby County to designate as an Industrial Park as provided for in Act No. 604, adopted by the Legislature of the State of Alabama on May 1, 1978, the compact and contiguous tract of land which is described in narrative fashion on Exhibit A hereto, and which is shown on maps attached hereto as Exhibit C (pages 1-5), such tract being more than ten acres in total size, located wholly within Shelby County, outside the boundaries of any municipality, owned 100 percent in interest based on assessed value for ad valorem tax purposes by Alabama Power Company, and which is used exclusively for industrial purposes or which is primarily suited for industrial development.

2. The tract of land herein requested by Alabama Power Company to be designated as an Industrial Park includes the lands heretofore designated by the County Commission of Shelby County as an Industrial Park on to wit December 16, 1981. Also included in this request is an additional tract of land which is described in narrative fashion on Exhibit B hereto and which is shown by map which is attached as Exhibit C (page 5).

3. Alabama Power Company requests that the Commission, prior to rendering the above requested designation, shall hold a public hearing on this petition, after first giving notice of the purpose, time and place of the public hearing by one publication in a newspaper of general circulation throughout Shelby County not less than ten days prior to the date set for the hearing.

4. The below identified representative of Alabama Power Company hereby certifies that all of the above
