EASEMENT

KNOW ALL MEN BY THESE PRESENTS, that in consideration of the mutual benefits to be derived by each, we the undersigned parties,

to the extent of our respective ownership and interest, do hereby grant and convey to each and all of the parties hereto a permanent, non-exclusive sixty (60) foot wide right-of-way for a roadway and utilities, as set forth below, over, across and under the Northeast Quarter of the Southwest Quarter, Southeast Quarter of the Northwest Quarter, Southwest Quarter of the Northeast Quarter, Northwest Quarter of the Northeast Quarter, and the Northeast Quarter of the Northeast Quarter, all in Section 5, Township 21 South, Range 2 West and the Southeast Quarter of the Southeast Quarter of Section 32, Township 20 South, Range 2 West, all in Shelby County, Alabama. The herein described right-of-way lies thirty (30) feet on each side of a center line described as follows:

Beginning at the Southeast corner of the Southeast Quarter of the Northwest Quarter of Section 5, Township 21 South, Range 2 West: Thence North along the East line of said quarter-quarter section a distance of 942.44 feet to a point designated point A., on the center line of a 60 foot right-of-way on which now exists a cherted road; thence turn left 129° 45' and run in a southwesterly direction along the center line of said 60 foot right-of-way 1,274.66 feet to the beginning of a curve to the left, said curve being subtended by a central angle of 29° 06' 35", having a radius of 577.72 feet, thence along said curve a distance of 293.46 feet to the point of a tangent, thence along said tangent 68 feet to the intersection of the center line of an existing cherted road, said point being the southwesterly end of the right-of-way herein described and located in the Northeast Quarter of the Southwest Quarter of said Section 5. Also begin at said point A located on the East line of the Southeast Quarter of the Northwest Quarter of said Section 5; thence run in a northeasterly direction along the center line of said cherted road through the Northwest Quarter of the Southwest Quarter of the Northeast Quarter of said Section 5, through the Southeast diagonal half of the Northwest Quarter of the Northeast Quarter of said Section 5, through the Northwest diagonal half of the Northeast Quarter of the Northeast Quarter of said Section 5, all in

Township 21 South, Range 2 West; thence continue in a northeasterly direction along the center line of said cherted road through the South half of the Southeast Quarter of the Southeast Quarter of Section 32, Township 20 South, Range 2 West, thence continue in a northeasterly direction along center line of said cherted road (1127) eleven hundred twenty seven feet into the Southwest Quarter of the Southwest Quarter of Section 33, Township 20 South, Range 2 West. Herein being the northeasterly end of said right-of-way.

In addition to other rights hereby granted to the parties, any party shall have the right, but shall not be obligated, to: (a) construct a road upon all or any portion of the right-of-way; (b) grade and/or pave, from time to time, all or any portion of the right-of-way; (c) use, maintain and repair any such road, including the shoulders thereof; (d) install, or have installed, on, over and/or beneath the surface of the land across which the right-of-way is located, fixtures, equipment, appliances, poles, wires, pipelines and other lines and facilities which are necessary or desirable to obtain sewer, gas, electric, water, telephone and any other utility service; and (e) maintain, repair and replace all such utility fixtures, equipment, appliances, poles, wires, pipelines and other lines and facilities. Any party shall have the right, but not the obligation, to dedicate the road to Shelby County or to the appropriate municipality and if any party wishes to dedicate the road to Shelby County or to such municipality, the remaining party or parties agree to cooperate with regard to such dedication and to do such things and to take such action as may be necessary to accomplish the dedication of the road.

The parties agree that they shall not, and shall not have the right to, place or install any improvements, structures or any other property, real or personal, under, upon or above the right-of-way which may interfere with the rights of other parties under this instrument.

This instrument shall be binding upon and inure to the benefit of all the parties, and their heirs, personal representatives, assigns, tenants, invitees and designees.
