That in consideration of EIGHTY-EIGHT THOUSAND, EIGHT HUNDRED AND NO/100 DOLLARS (\$88,800.00)

to the undersigned grantor, ROY MARTIN CONSTRUCTION, INC., a corporation,
(herein referred to as GRANTOR), in hand paid by the GRANTEEES herein, the receipt of which is hereby acknowledged, the
said GRANTOR does by these presents, grant, bargain, sell and convey unto

WAYNE H. SMITH, a single man, and MELANIE J. HERRING, a single woman,

(herein referred to as GRANTEEES) for and during their joint lives and upon the death of either of them, then to the survivor
of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate,
situated in Shelby County, Alabama, to-wit:

Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama.
