KNOW ALL MEN BY THESE PRESENTS:

(herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto

George R. Carden

(herein referred to as grantee, whether one or more), the following described real estate, situated in

Shelby County, Alabama, to-wit:

Commence at the Northeast corner of the SW $\frac{1}{4}$ of the NE $\frac{1}{4}$, Section 36, Township 20 South, Range 1 East, thence run South along the East line of said $\frac{1}{4}$ - $\frac{1}{4}$ Section a distance of 637.56 feet to the point of beginning; thence continue South along the East line of said $\frac{1}{4}$ - $\frac{1}{4}$ Section a distance of 667.27 feet to the Southeast corner of said $\frac{1}{4}$ - $\frac{1}{4}$ Section; thence turn an angle of 88 degrees 39 minutes 15 seconds to the right and run West along the South line of said $\frac{1}{4}$ - $\frac{1}{4}$ Section a distance of 1332.05 feet to the Southwest corner of said $\frac{1}{4}$ - $\frac{1}{4}$ Section; thence turn an angle of 91 degrees 16 minutes 03 seconds to the right and run North along the West line a distance of 1293.20 feet to the Northwest corner of said $\frac{1}{4}$ - $\frac{1}{4}$ Section; thence turn an angle of 88 degrees 14 minutes 02 seconds to the right and run East along the North line a distance of 995.77 feet, more or less, to a point on Spring Branch; thence turn an angle of 28 degrees 20 minutes 25 seconds to the right and run along said Spring Branch a distance of 213.57 feet; thence turn an angle of 126 degrees 39 minutes 37 seconds to the right and run a distance of 609.29 feet, more or less; thence turn an angle of 90 degrees 00 minutes to the left and run a distance of 503.67 feet; thence turn an angle of 85 degrees 47 minutes 26 seconds to the left and run a distance of 501.84 feet to the point of beginning; situated in the SW $\frac{1}{4}$ of the NE $\frac{1}{4}$, Section 36, Township 20 South, Range 1 East, containing 31.59 acres, more or less.
