That for and in consideration of Eighteen Thousand Seven Hundred Seventy-Six and 86/100 (\$18,776.86) Dollars, to the undersigned grantors, JEANETTE GEORGE LANEY and husband, JOHN C. LANEY, in hand paid by LEWIS B. WALKER, the receipt whereof is hereby acknowledged, we the said Jeanette George Laney and husband, John C. Laney, do hereby grant, bargain, sell and convey unto the said Lewis B. Walker, all merchantable timber located on the following described land:

The SW $\frac{1}{4}$  of the NW $\frac{1}{4}$  of Section 35, Township 21, Range 1 West, situated in Shelby County, Alabama, containing 40 acres, more or less,

together with full and free right of ingress and egress to and from said land at any and all times until the expiration of Twelve (12) months from the date of the execution of this deed, for the purpose of cutting and removing said timber, but after said time, grantee shall have no further rights or interest in said land or timber uncut and at the expiration of said time, said land and all uncut timber shall revert to the grantors herein.

It is understood and agreed that grantee is hereby given the right to use existing private roads and has the right to build such temporary roads and other devices as may be necessary or useful to the grantee for the purpose of cutting and removing the timber, however, all roads are to be left in as good condition as at the beginning of this contract.

And we do for ourselves and for our heirs, executors and administrators covenant with the said Lewis B. Walker, his successors and assigns, that we are lawfully seized of said premises


