Moore and wife, Annette P. Moore, being the sole and surviving heirs at law of Onnie E. Phillips, deceased, in hand paid by Lomax Pulpwood and Lumber Company, Inc. the receipt whereof is hereby acknowledged, we, the said T. W. Dison and wife, Ruth P. Dison; C. J. together with full and free right of ingress and egress to and from said land at any and all times until May 22, 1966, for the purpose of cutting and removing said timber, but after said time, grantee shall have no further rights or interest in said land or timber and at the expiration of said time, said land and all uncut timber shall revert to the grantors herein.
