KNOW ALL MEN BY THESE PRESENTS, THAT:

WHEREAS, the undersigned is the owner of the right to receive all or a part of the delay rentals or other payments which may be paid by depositing the same to the credit of the owners thereof in the depository bank named in the following described oil, gas and mineral lease:

covering and affecting the following described land, situated in the County of Shelby

Section 24: Begin at the Southeast corner of the SW $\frac{1}{4}$ of SE $\frac{1}{4}$; thence North 628 feet to a stake; thence in a westerly direction 438 feet to a stake; thence in a North-easterly direction 131 feet to a stake; thence in a Westerly direction 321 feet to a stake; thence South 862 feet to the intersection of the forty acre east and west line; thence East along said line 660 feet to the point of beginning and containing 12 acres, more or less.

No. 484 3841 5 bank of Birmingham, AL as the depository bank to receive and receipt for all payments which may be made to the undersigned through a depository bank under the terms of said lease, and Amoco Production Company is hereby fully authorized and empowered to deposit any such payments to the undersigned's credit in said bank, all to the same extent and purpose as if said bank had been named originally in said lease as the depository bank for the undersigned.

It is agreed and declared that, as amended by the change of the designated depository bank to the extent of the undersigned's interest as aforesaid, said lease is now in full force and effect and we the undersigned, and each of us, do hereby ratify, approve, confirm, and adopt the above described oil and gas lease insofar as it covers the above described land, and do hereby grant, lease, demise, and let said land to Amoco Production Company subject to and under the terms and provisions of said lease; that payment has been duly made of the entire bonus consideration and all of the delay rentals necessary to extend said lease to the next rental paying date.

The terms and provisions hereof shall be binding on the undersigned and the successors in interest of the undersigned.
