

KNOW ALL MEN BY THESE PRESENTS:

That, WHEREAS, that certain oil and gas lease, dated June 7, 1982, from

of the Lease Records of Shelby County, Alabama is owned by

Gay, recorded in Deed Book 287, Page 208, May 27, 1976, Shelby County, Alabama, consisting of 3.9 acres and described as follows; Begin at the intersection of the East line of Section 24, Township 18 South, Range 1 East and the North right of way of County Road 45; Thence Northeasterly a distance of 230 feet; thence Northwesterly 438.5 feet; thence Southwesterly to the Northeast right of way of County road 45; thence Southeasterly along the North right of way of County road 45 to the point of beginning.

Begin at the intersection of May Street and Pine Street; thence Southwest on the Northwest right of way of May Street a distance of 120 feet to the point of beginning of the tract of land herein described; thence continue Southwest on the Northwest right of way of May Street 131.5 feet; thence Northwest 280 feet to the West boundary line of Section 19, township 18 South, Range 2 East; Thence North on the West boundary of said Section 19 a distance of 190 feet; thence Southeast a distance of 415 feet to the point of beginning, Section 19, Township 18 South, Range 2 East.

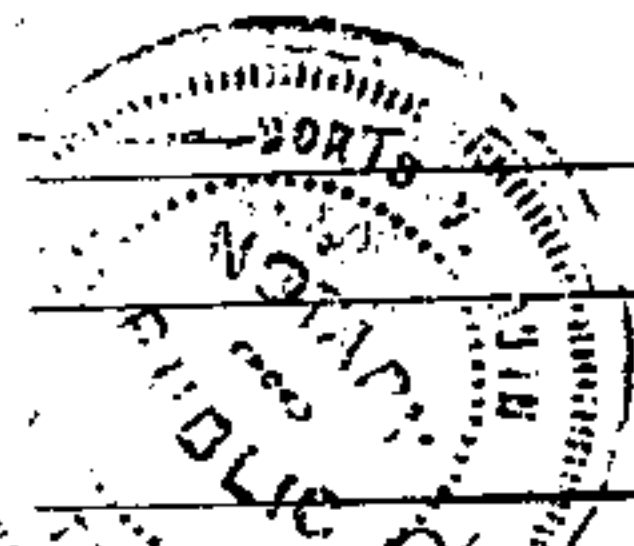
