CLAIM OF LIEN

1. The undersigned RONNIE L. JACKSON is the Executive Vice President of J. H. BERRY & COMPANY, INC., and as such officer, has full knowledge of the facts expressed below.

2. That said J. H. BERRY & COMPANY, INC. claims a lien upon the following property, situated in Jefferson County, Alabama, to wit:


A part of the NE 1/4 of the SW 1/4 of Section 31, Township 18 South, Range 1 East. More particularly described as follows: Begin at the NW corner of said 1/4-1/4 section and run South along the West line of said 1/4-1/4 section 153.03' to an iron. Thence turn angle of 43 degrees 29' 24" to the left and run in a Southerly direction 1190.20 feet to an iron on the Westerly right of way line of Montevallo Road Shelby County #43. Thence run in a Northeasterly direction along said right of way line a distance of 419.20 feet to a point thence turn an angle of 86 degrees and 31' to the left and run in a Northwesterly direction a distance of 1,003.38 feet to the North line of said 1/4-1/4 section. Thence run West along the North line of said 1/4-1/4 section a distance of 374.96 feet to the point of beginning.

3. This lien is claimed, separately and severally, as to both the buildings and improvements thereon, and the said land, in the name of Lee J. York and Marsha M. York.




