CORPORATION FORM WARRANTY DEED, JOINTLY FOR LIFE WITH REMAINDER TO SURVIVOR

That in consideration of Seventy-Two Thousand Five Hundred and no/100-----

to the undersigned grantor, FIRST NATIONAL BANK OF COLUMBIANA a corporation,
 (herein referred to as GRANTOR), in hand paid by the GRANTEES herein, the receipt of which is hereby acknowledged, the
 said GRANTOR does by these presents, grant, bargain, sell and convey unto

JAMES R. WALKER and JULIE A. WALKER

(herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor
 of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate,
 situated in Shelby County, Alabama, to-wit:

Commence at the Northeast corner of the NW $\frac{1}{4}$ of the SE $\frac{1}{4}$, Section 4, Township 20 South, Range
 1 West, thence run South along the East line of said $\frac{1}{4}$ - $\frac{1}{4}$ Section a distance of 193.00 feet
 to the point of beginning; thence continue South along the East line of said $\frac{1}{4}$ - $\frac{1}{4}$ Section
 a distance of 14.26 feet to the center of the old Birmingham-Columbiana Road; thence turn
 an angle of 122 degrees 58 minutes 54 seconds to the right and run along said road a distance
 of 265.91 feet to the Southeast right-of-way of Shelby County Highway No. 39; thence turn
 an angle of 115 degrees 44 minutes 31 seconds to the right and run along said highway right-
 of-way a distance of 66.97 feet; thence turn an angle of 2 degrees 11 minutes 45 seconds
 to the left and continue along said highway right-of-way a distance of 48.52 feet; thence
 turn an angle of 1 degree 50 minutes 28 seconds to the left and continue along said highway
 right-of-way a distance of 25.00 feet; thence turn an angle of 83 degrees 22 minutes 48
 seconds to the right and run a distance of 276.83 feet; thence turn an angle of 131 degrees
 29 minutes 21 seconds to the right and run a distance of 80.00 feet to the point of beginning.
 Situated in the SW $\frac{1}{4}$ of the NE $\frac{1}{4}$ and the N $\frac{1}{4}$ of the SE $\frac{1}{4}$, Section 4, Township 20 South, Range
 1 West, Shelby County, Alabama, and containing 0.60 acres, more or less. Mineral and Mining
 rights excepted.

SUBJECT TO easements, restrictions and rights-of-way of record, and the rights of redemption
 under the laws of the State of Alabama.

 tingent remainder and right of reversion. And said GRANTOR does for itself, its successors and assigns, covenant with said
 GRANTEES, their heirs and assigns, that is lawfully seized in fee simple of said premises, that they are free from all encum-
 brances,

that it has a good right to sell and convey the same as aforesaid, and that it will and its successors and assigns shall, warrant
 and defend the same to the said GRANTEES, their heirs, executors and assigns forever, against the lawful claims of all persons.
