ALSO: that certain tract of land described as commencing at the point of intersection of the North right-of-way line of the Florida Short Route Highway (#280) with the West line of the SE 1/4 of NW 1/4 of Section 26, Township 19 South, Range I West and run thence in an Easterly direction a distance of 262.5 feet to the point of beginning of the tract herein described; run thence North and parallel to the West line of said 1/4-1/4 section for a distance of 591 feet to a point being in settlement road; thence run in a Southwesterly direction along said settlement road for a distance of 630 feet, more or less, to a point on the North R/W of aforementioned highway; thence run East along said R/W for a distance of 112 feet to the point of beginning.
