CORRECTIVE RIDER TO MORTGAGE

This RIDER TO MORTGAGE is made this 20th day of Somewher , 19 85 , and is incorporated into and whall be deemed to amend and supplement that certain Mortgage (hereinafter referred to as "Mortgage") executed simultaneously herewith by the undersigned (hereinafter referred to as "Mortgagor") to secure Mortgagor's Note to Liberty Mortgage Corporation (hereinafter referred to as "Mortgagee") and covering the property described in the Mortgage.

In addition to the covenants and agreements made in the Mortgage, Mortgagor and Mortgagee further covenant and agree as follows:

- A. To amend Paragraphs No. 2 and 3 of said Mortgage by deleting the same in its entirety and in lieu thereof substituting the following language, to-wit:
 - 2. Together with and in addition to the monthly payments of principal and interest payable under the terms of the note secured hereby, the Mortgagor will pay to the Mortgagee, on the first day of each month until said Note is fully padd, the following sums:

 - (i) ground rents, taxes, special assessments, fire and other hazard insurance premiums;
 - (ii) interest on the note secured hereby; and
 - (iii) amortization of the principal of said note.
