KNOW ALL MEN BY THESE PRESENTS:

That in consideration of Ten and No/100 (\$10.00) and other good valuable considerations

to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt whereof is acknowledged, I or we, KENNETH W. BRAST and wife, CYNTHIA H. BRAST

(herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto WILLIAM D. MURRAY, JEAN MURRAY, KENNETH W. BRAST and CYNTHIA H. BRAST

(herein referred to as grantee, whether one or more), the following described real estate, situated in Shelby County, Alabama, to-wit:

From the Northwest corner of Section 22, Township 22 South, Range 3 West, run Southerly along the West side of the said section for 1307.47 feet to the Northwest corner of the SW 1/4 of NW 1/4; thence turn an angle of 88 deg. 39 min. 50 sec. to the left and run Easterly for 130.20 feet; thence turn an angle of 88 deg. 46 min. 50 sec. to the right and run Southerly for 139.50 feet to the point of beginning (said point being on the South right of way of Davila Drive); thence continue along the last described course for 208.28 feet; thence turn an angle of 88 deg. 25 min. 10 sec. to the right and run Westerly for 50.02 feet; thence an angle of 91 deg. 34 min. 30 sec. to the right and run Northerly for 205.70 feet to a point on the South right of way of Davila Drive; thence turn an angle of 85 deg. 28 min. to the right and run Easterly for 50.16 feet back to the point of beginning; being a portion of the SW 1/4 of the NW 1/4 of Section 22, Township 22 South, Range 3 West; being situated in Shelby County, Alabama.
