Amendment of articles of incorporation of The Alabama Association of Public Employees, Inc, a nonprofit corporation organized under the laws of the State of Alabama, executed by William M. Martin of Post Office Box 400, City of Pelham, County of Shelby, its Vice-President, and Lindell Graham of Route 1, City of Delta, County of Clay, its Secretary and Treasurer.

The corporation was organized on the 13th. day of December, 1982.

The corporation, on the proposal of its board of directors by resolution duly adopted by said board and passed by the appropriate vote at a meeting held on September 23, 1985 in accordance with Article Fifteen of the Articles of Incorporation and with Sections 5.2, 5.9, 5.10 of the Constitution of the Corporation, adopted the following amendment to the Articles of Incorporation of the Alabama Association of Public Employees:

Be it resolved that Article Seventeen, Prohibition Against Specified Activities, be deleted in its entirety from the Articles of Incorporation of The Alabama Association of Public Employees, Inc. as filed in the office of the Probate Court of Shelby County Alabama on December 13, 1982, Book 23, Page 826.
