(Right of Way) line of highway No. 26, Thence turn an angle of 95 -27' to the left and run a distance of 127.09' to a point, Thence turn an angle of 1 -40' to the right and run a distance of 275.43' to a point, Thence turn an angle of 3 -23' to the right and run a distance of 702.59' to the point of beginning of the property being described, Thence continue along last described course along the North right of way line of Shelby County Highway 26, a distance of 252.08' to a point, Thence turn an angle of 94 -12' to the right and run Southerly a distance of 87.88' to a point, Thence turn an angle of 40 -42' to the right and run Southwesterly a distance of 69.54' to a point, Thence turn an angle of 55 -48' to the right and run Northwesterly a distance of 193.51' to a point, Thence turn an angle of 75 -40' to the right and run Northerly a distance of 101.18' to the point of beginning, containing 28,729.26 square feet.

THIS IS A PURCHASE MONEY MORTGAGE.

Said property is warranted free from all incumbrances and against any adverse claims.

TO HAVE AND TO HOLD the above granted premises unto the said Mortgagee forever; and for the purpose of further securing the payment of said indebtedness, the undersigned, agrees to pay all taxes, or assessments, when legally imposed upon said premises, and should default be made in the payment of same, said Mortgagee has the option of paying off the same; and to further secure said indebtedness, the undersigned agrees to keep the improvements on said real estate insured against loss or damage by fire, lightning and tornado for the reasonable insurable value thereof, in companies satisfactory to the Mortgagee, with loss, if any, payable to said Mortgagee, as the interest of said Mortgagee may appear, and promptly to deliver said policies, or any renewals of said policies, to said Mortgagee; and if undersigned fail to keep said property insured as above specified, or fail to deliver said insurance policies to said Mortgagee then said Mortgagee has the option of insuring said property for said sum for the benefit of said Mortgagee, the policy, if collected, to be credited on said indebtedness, less cost of collecting same; all amounts so expended by said Mortgagee for taxes, assessments or insurance, shall become a debt to said Mortgagee, additional to the debt hereby specially secured, and shall be covered by this mortgage, and bear interest from the date of payment by said Mortgagee, and be at once due and payable.
