



East a distance of 214.2 feet to a point; thence turn an angle to the left of 00 degrees 38 minutes and run North 35 degrees 45 minutes East a distance of 1274 feet, more or less, to a point on the Southerly boundary line of the Grantor's property, such point being the point of beginning of the right of way herein described; therefrom, the strip lies 20 feet on each side of a center line and the continuations thereof which begins at such point of beginning and runs North 35 degrees 45 minutes East a distance of 120.1 feet to a point; thence such center line turns an angle to the left of 01 degree 40 minutes and runs North 34 degrees 05 minutes East a distance of 283.3 feet to a point; thence such center line turns an angle to the left of 07 degrees 46 minutes and runs North 26 degrees 19 minutes East a distance of 102 feet, more to less to a point on the Northerly boundary line of the Grantor's property, such point being the point of ending of the right of way herein described.

TO HAVE AND TO HOLD the same to the said Company, its successors and assigns, forever.

The grantors shall have the right to cultivate and use said strip of land for any purpose not inconsistent with the rights which the grantee may from time to time exercise hereunder.




