

WAIVER BY MINERAL LESSEE OF RIGHT TO USE SURFACE

KNOW ALL MEN BY THESE PRESENTS, THAT:

Atlantic Richfield Company, a Delaware corporation, whose address is P. O. Box 2819, Dallas, Texas 75221, for Ten Dollars (\$10.00) and other valuable considerations in hand paid by Gulf States Paper Corporation, a Delaware Corporation of P.O. Box 3199, Tuscaloosa, AL 35401, receipt of which is hereby acknowledged, does hereby waive, release and relinquish its right to enter upon and use the surface of said land for any and all purpose including, but not limited to, drilling wells, laying and/or constructing pipelines, and building tanks, power stations, roads, electric lines, telephone lines and other structures, situated in Shelby County, State of Alabama, insofar and only insofar as it covers that described as follows, to wit:

Township 20 South - Range 1 West
Section 22: E 1/2 of SW 1/4 of NW 1/4
containing 20 acres, more or less.

Under and pursuant to the terms of that certain Oil and Gas Lease dated August 24, 1979, between Gulf State Paper Corporation, as Lessor, and Atlantic Richfield Corporation, as Lessee, and a memorandum of which was recorded in Deed Book 324 at Page 385 in the records of Shelby County in the State of Alabama. Atlantic Richfield Company hereby reserves and retains all rights under the above-described lease not specifically released herein, including the right to explore for and produce oil and/or gas from the above-described premises through directional drilling or other means..
