KNOW ALL MEN BY THESE PRESENTS, That for and in consideration of the sum of TWELVE HUNDRED FIFTY AND NO/100 (\$1250.00) DOLLARS paid in cash and the additional sum of \$2,500.00 to be paid in accordance with agreement between the grantor and the grantee in hand paid to the undersigned, the receipt whereof is hereby acknowledged, the undersigned

Helen Odell Allen, an unmarried woman

hereby remises, releases, quit claims, grants, sells, and conveys to

W. C. Allen

(hereinafter called Grantee), all my right, title, interest and claim in or to the following described real estate, situated in Shelby County, Alabama, to-wit:

From the NE corner of SE $\frac{1}{4}$  of NW $\frac{1}{4}$  of Section 18, Township 18 South, Range 2 East, run thence South along the East line of said  $\frac{1}{4}$  Section a distance of 330 feet; thence turn right 90 deg. 51' a distance of 210 feet to the Southwest corner of a parcel heretofore conveyed to Franklin Weldon and wife, Virginia Weldon which is the point of beginning of the parcel herein described; thence left 91 deg. 00' a distance of 420 feet; thence right 90 deg. 51' a distance of 443.02 feet; thence right 88 deg. 27' a distance of 682 feet; thence right 84 deg. 57' a distance of 448 feet to the Northwest corner of said Weldon parcel; thence run South along the West line of said Weldon parcel a distance of 330 feet, more or less, to the point of beginning, according to survey of Evander E.
