A portion of the East $\frac{1}{2}$ of the SE $\frac{1}{4}$ of Section 10, and the West $\frac{1}{2}$ of the SW $\frac{1}{4}$ of Section 11, Township 22 South, Range 3 West described as follows: Begin at the SW corner of Section 11, Township 22 South, Range 3 West and run easterly along the south side of the said section 11 for 985.12 feet, then turn an angle of 91 degrees 43' to the left and run northerly for 1316.18 feet, then turn an angle of 55 degrees 18' 15" to the left and run northwesterly for 552.5 feet to the point of beginning of the property herein described and the point of beginning of a 30 ft. wide easement included herewith. Then turn an angle of 90 degrees 00' to the left and run southeasterly for 240.00 feet, then turn an angle of 90 degrees 00' to the left and run northeasterly 213.00 feet, then turn an angle of 90 degrees 00' to the left and run northeasterly for 213.00 feet, then turn an angle of 90 degrees 00' to the left and run northwesterly for 240.00 feet back to the point of beginning. From said point of beginning then continue along the last described course running northwesterly (and along the northeast side of a 30 ft. wide access easement for the property described above) for 1127.07 feet to a point on the southeast right of way of State Highway #119, said point being the point of ending of the 30 ft. wide access easement.
