It is CONSIDERED, ORDERED AND ADJUDGED:

That judgment be and the same is rendered in favor of the Plaintiff, CITY FINANCE COMPANY OF CLANTON and against the Defendant JERRY A. BRAMLETT & DARLENE BRAMLETT for the sum of Five Thousand & No/100 Dollars and the sum of Sixty & No/100 Dollars Costs of Court, for which execution may issue for enforcement and collection of the debt as fully as if bankruptcy had not intervened, and the said debt shall be excepted from the discharge if and when one is granted in this case, and the Plaintiff shall have the right of all legal process for the full satisfaction and enforcement thereof.

It is further ORDERED:

That payment of the judgment and costs herein shall be made directly to attorney or attorneys of record for the Plaintiff and that, upon receipt thereof, such attorneys will satisfy said judgment of record.
