ARTICLES OF DISSOLUTION OF

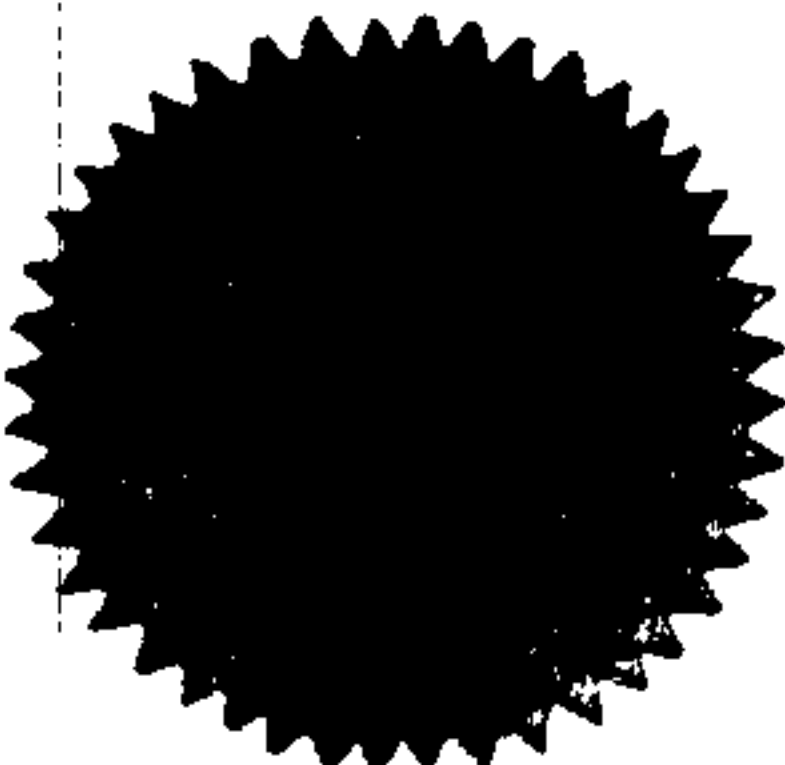
