ARTICLES OF INCORPORATION

of

The undersigned acting as incorporator of a business corporation under the Alabama Business Corporation Act, hereby adopts the following Articles of Incorporation:

1. Name: The name of the corporation is: SKYHAWK MINING CORPORATION.
2. Period of Duration: The period of duration of the corporation shall be perpetual.
3. Purposes: The purpose for which this corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Alabama Business Corporation Act.
4. Authorized Shares: The aggregate number of shares of stock which the corporation shall have the authority to issue shall be five thousand (5,000) shares of common stock of the par value of One Dollar (\$1.00) per share.
5. Registered Office/Initial Registered Agent: The location and mailing address of the corporation's registered office is Rt 1, Fox Valley Mart-B, Maylene, Alabama 35114, and the name of the initial registered agent at such address is Annorah Jo Cox.
6. 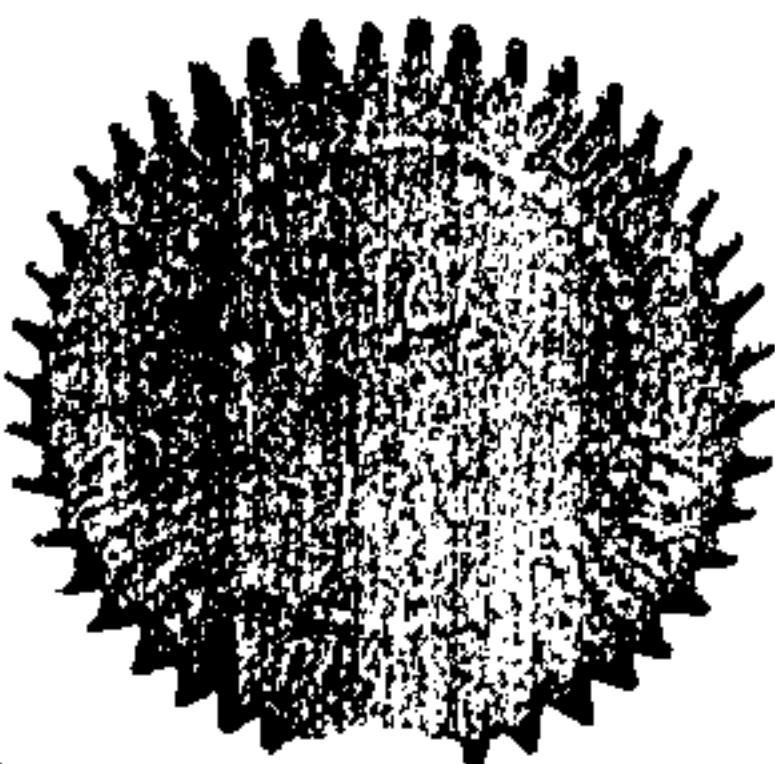
CERTIFICATE OF INCORPORATION OF
