LACKEY, individually and doing business as MID-SOUTH SALES CO. whose address is Route Two, Box 227, Columbiana, Alabama 35201, as shown in the Court proceeding TWENTY THREE THOUSAND EIGHT HUNDRED FORTY FIVE AND 18/100 (\$23,845.18) DOLLARS, together with interest thereon in the sum of FIVE HUNDRED SIXTY FIVE AND 54/100 (\$565.54) DOLLARS, for a total of TWENTY FOUR THOUSAND FOUR HUNDRED TEN AND 72/100 (\$24,410.72) DOLLARS.

It was further ORDERED, ADJUDGED and DECREED by the Court that in addition to the foregoing, plaintiff have and recover of defendant DAVID W. LACKEY, individually and doing business as MID-SOUTH SALES CO., the sum of TWO THOUSAND SIX HUNDRED EIGHTY SIX AND 25/100 (\$2,686.25) DOLLARS as a reasonable attorneys' fee recoverable under Alabama law by virtue of defendant's issuance of a worthless check.

It was further ORDERED by the Court that defendants pay direct to the attorneys of record for plaintiff the proceeds of the judgment, interest, and attorneys' fees recovered herein by plaintiff, and upon receipt thereof, the attorneys of record for the Plaintiff will satisfy the said judgment on the records of this Court; and that Lee R.
