RESTRICTIONS FOR WINDSOR ESTATES

Whereas, the undersigned, Cornerstone Properties, Inc. is the owner of all the lots in Windsor Estates.

Whereas, the undersigned Cornerstone Properties, Inc. hereinafter referred to as "Owner" is desirous of establishing restrictions and limitations applicable to all lots owned by them in said subdivision, which said subdivision is recorded in Map Book _____, Page _3___, office of the Judge of Probate of Shelby County, Alabama.

Now, THEREFORE, the undersigned Cornerstone Properties, Inc. does hereby adopt the following restirctions and limitations which are as follows:

- 1. That said property be used for residence purposes only and not for any purpose of business or trade.
- 2. No more than one residence shall be constructed on any one lot in said subdivision and any residence so constructed shall be a one family dwelling.
- 3. No dwelling shall be erected in said Windsor Estates unless the following listed minimum square footage requirements are complied with (exclusive of porches or garages):
 - (A.) One story structure 2400 square feet.
 - (B.) One and one-half $(1\frac{1}{2})$ story structure 2800 square feet total with a minimum of 1800 square feet on the first floor.
 - (C.) Two (2) story structure 3000 square feet total with a minimum of 1500 square feet on the first floor.
- 4. No structure of a temporary character, trailer, basement, tent, shack, garage, barn or other outbuildings shall be used on any lot at any time as a residence either temporarily or permanently.
- 5. No fences of any kind shall be erected within the area of the minimum building set back line as shown on the recorded plat and no chain link fences shall be permitted, unless approved by the Architectural Control Committee in writing.
- 6. No lot may be subdivided or reduced in size by voluntary alienation, judicial sale, or other proceedings, except in the discretion and with the written prior approval of said owners, their heirs, executors or assigns.
- 7. No animals will be allowed except for dogs, cats, pet birds limited to a per lot aggregate of four and no breeding of any animals for commercial purposes shall be permitted.

- 8. No exterior radio or television antennas shall be permitted if they are visible from the street in front of each dwelling. No satellite dish antennas shall be permitted, unless approved by the Architectural Committee in writing.
- 9. No building shall be erected, placed or altered on any lot until the construction plans and specifications and the plans showing the location of the construction have been approved by the Architectural Control Committee as to quality and workmanship and materials, harmony of external design with existing topography and finish grade elevation.

The Committee's approval or disapproval as required in these covenants shall be in writing. In the event the Committee or its' designated representative fail to approve or disapprove within 30 days after plans and specifications have been submitted to it or in any event if no suit to enjoin the construction has been commenced after the completion thereof, approval will not be required and the related covenant shall be deemed to have been fully complied with.

- 10. All basketball goals shall be attached to a goal post and no goals may be attached to the dwelling.
- 11. All yards shall be landscaped so as to blend harmoniously with the other dwellings and lots in the subdivision.
- 12. All dwellings must contain wooden window frames. All aluminum window frames are prohibited unless approved by Architectural Control Committee.
- 13. The pitch of the roof on the dwelling must be at least 7 in 12 or more.
- 14. All mail boxes shall be in a style and design to blend harmoniously with the other mail boxes in the subdivision.
- 15. No wooden front porches shall be permitted. All front proches must be of brick or masonry material.
- other type vehicle shall be parked or maintained on any permanent basis on any lot. Only vehicles used for day-to-day transportation of the property owners, their families or invitees may be kept or stored on the property. No house trailers, campers, boats, dune buggys, or inoperatable vehicles may be kept or stored on the premises.
- 17. No lot shall be sold or used for the purpose of extending any public or private road, street, or alley, or for the purpose of opening any road, street or alley except by the prior written consent of said owners, their heirs, executors and assigns.
- 18. No privy or receptical of any kind can be used for storage or waste and only septic tanks and sewage disposal systems approved by the County health department shall be acceptable.
- 19. No noxious or offensive activity shall be carried on upon any lot, nor shall anything be done theron which may be or may become an annoyance or nuisance to the neighborhood.
- 20. No sign of any kind shall be displayed to the public view on any lot except, one sign of not more than five square feet advertising the property for sale or rent, or signs used by a builder to advertise the property during the construction and sales period.
- 21. No building shall be located on any lot nearer to the front lot line or nearer to the side street line than the minimum building set back line as shown on the recorded plat. In any event, no building shall be located on any

lot nearer than 35 feet to the front lot line. No building shall be located nearer than 8 feet to the interior lot line. For the purpose of this covenant, eaves, steps and open porches shall not be considered as a part of the building, provided, however, that this shall not be construed to permit any portion of the building on a lot to encroach upon another lot.

- 22. Easements to each individual lot for installation and maintenance of utilities and drainage facilities are reserved as set out in the recorded plat. The granting of this easement or right of access shall not prevent the use of the area by the owner for the permitted purpose except for building. A right of pedestrain access by way of driveway or open lawn area shall also be granted on each lot, from the front line to the rear lot line, to any utility company having an installation in the easements.
- 23. No oil drilling, oil development, operations, oil refining, quarrying or mining operations of any kind shall be permitted upon or in any lot, nor shall oil wells, tanks, tunnels, mineral excavations or shafts be permitted upon or in any lot. No derrick or other structure designed for use in boring for oil or natural gas shall be erected, maintained or permitted upon any lot.
- 24. No fence, wall, hedge or shrub planting which obstructs sight lines at elevations between 2 and 5 feet above the roadways shall be placed or permitted to remain on any corner lot within the triangular area formed by the street property lines and a line connecting them at points 25 feet from the intersection of the street lines, or in the case of a rounded property corner from the intersection of the street property lines extended. The same sightline limitations shall apply on any lot within 10 feet from the intersection of a street property line with the edge of a driveway or alley pavement. No tree shall be permitted to remain within such distances of such intersections unless the foliage line is maintained at sufficient height to prevent obstructions of such sight lines.
- 25. The restrictions shall not be taken as permitting any action or thing prohibited by the applicable zoning laws, or the laws, rules or regulations of any governmental authority, or by specific restrictions imposed by any deed or lease. In the event of any conflict, the most restrictive provision of such laws, rules regulations, deeds, leases or the restrictions shall be taken to govern and control.

- It is understood and agreed that said conditions, limitations, and restrictions shall attach to and run with the land for a period of 25 years from date hereof, at which time said restrictions and limitations shall automatically extend for successive periods of ten years, unless by vote of a majority of the then owners of the lots, it is agreed in writing to change said restrictions, in whole or in part. If the parties hereto, or any of them, or their heirs, or assigns shall violate or attempt to violate any of the covenants herein, it shall be lawful for any other person or persons owning real property situated in said development or subdivision to prosecute any proceeding at law or in equity against the person or persons violating or attempting to violate any such covenant and either to prevent him or them from doing or to recover damages or other dues from such violations.
- Owners, their heirs, executors, assigns and successors, reserve the right to modify, release, amend, void, transfer, or delete all of the rights, reservations and restrictions herein set forth, or the right to modify, release, amend, or void any one of them or more of the said set forth restrictions on lots or estate belonging to them.

Invalidation of any one of these covenants by judgment or court order shall in no wise affect any of the other provisions which shall remain in full force and affect.
