LEGAL DESCRIPTION

A portion of land situated in the NE 1/4 of the NE 1/4 of Section 28, Township 21 South, Range 1 West, and being more particularly described as follows: Begin at the point of intersection of the West line of the NE 1/4 of the NE 1/4 of Section 28, Township 21 South, Range 1 West, Shelby County, Alabama, and the North right of way line of Shelby County Highway No. 70; from the point of beginning thus obtained, run North along the West line of said 1/4 1/4 Section a distance of 136.50 feet; thence turn right 100 deg. 05 min. and run Easterly a distance of 285.14 feet to the Westerly right of way line of Shelby County Road No. 26; thence from the last described course, turn right 79 deg. 13 min. 10 sec. and run Southerly along said right of way line a distance of 78.30 feet; thence turn right 48 deg. 39 min. 55 sec. and run Southwesterly along said right of way line a distance of 100.0 feet to the intersection with the North right of way line of Shelby County Road No. 70; thence turn right 48 deg. 39 min. 55 sec. and run West along said North right of way line a distance of 212.8 feet to the point of beginning; being situated in Shelby County, Alabama.
