

ARTICLES OF INCORPORATION  
OF  
SPORTSPECTRUM, INC.

The undersigned, acting as incorporators of a corporation under the Code of Alabama, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation shall be Sportspectrum, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are:

To sell to the general public, items relating to the sport and enjoyment of tennis, running, and aerobic-dance.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is one thousand (1000) shares of common stock of the par value of One Dollar (\$1.00) per share. The corporation will begin business with a capital stock of One Thousand Dollars (\$1,000.00) of which all will be paid in cash. All of the above stock will be common stock of the corporation and will have no other class of stock when it begins business.

FIFTH: Provisions for the regulation of the internal affairs of the corporation are: The corporate affairs shall be as set out in the By-Laws and Articles of Incorporation.

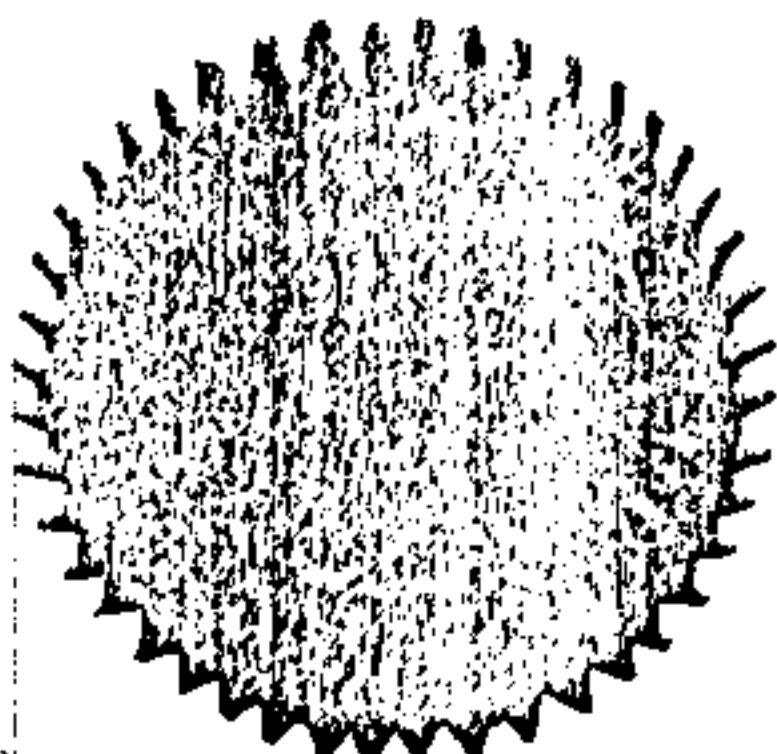
