A tract of land situated in the Southwest 1/4 of the Northeast 1/4 of Section 5, Township 19 South, Range 1 West, Shelby County, Alabama, more particularly described as follows: Begin at the Southeast corner of said SW 1/4 of NE 1/4 and run West along the South line thereof for 570.73 feet; thence turn right 90 deg. 02 min. 14 sec. and run Northerly for 225.98 feet; thence turn left 90 deg. and run Westerly for 60.15 feet; thence turn right 83 deg. 32 min. 25 sec. and run Northwesterly for 201.89 feet; thence turn right 96 deg. 27 min. 21 sec. and run Easterly for 228.15 feet; thence turn left 90 deg. 00 min. 10 sec. and run Northerly for 163.00 feet; thence turn right 90 deg. and run Easterly for 254.15 feet; thence turn right 90 deg. 27 min. 45 sec. and run Southerly for 218.26 feet; thence turn left 90 deg. and run Easterly for 176.0 feet to a point on the East line of said SW 1/4 of NE 1/4; thence turn right 90 deg. and run Southerly along said East line 369.62 feet to the point of beginning.
