(hereinafter called Grantee), all my right, title, interest, and claim in or to the following described real

estate, situated in Shelby

County, Alabama, to-wit:
TRACT 16: Part of the SE $\frac{1}{4}$ of NE $\frac{1}{4}$ of Section 29, Township 21 South, Range 1 West, Shelby County, Alabama, being more particularly described as follows: From the Northeast corner of said $\frac{1}{4}$ - $\frac{1}{4}$ Section, run in a Southerly direction along the East line of said $\frac{1}{4}$ - $\frac{1}{4}$ for a distance of 927.46 feet to the point of beginning; thence turn an angle to the right of 59 degrees 01 minutes 40 seconds and run in a Southwesterly direction for a distance of 639.47 feet to a point on a curve, said curve being concave in a Southwesterly direction and having a radius of 408.09 feet; thence turn an angle to the right of 88 degrees 44 minutes 20 seconds and run in a Northwesterly direction along the chord of said curve for a distance of 32.04 feet; thence turn an angle to the left of 2 degrees 15 minutes from last mentioned chord and run in a Northwesterly direction for a distance of 183.69 feet to a point of curve, said curve being concave in an Easterly direction and having a radius of 161.57 feet and a central angle of 34 degrees 46 minutes 52 seconds; thence turn an angle to the right and run along the arc of said curve for a distance of 98.08 feet to the end of said curve; thence run in a Northerly direction along a line tangent to end of said curve for a distance of 95.62 feet to a point of curve, said curve being concave in an Easterly direction and having a radius of 211.84 feet and a central angle of 10 degrees 30 minutes; thence turn an angle to the right and run in a Northerly direction along the arc of said curve for a distance of 38.82 feet; thence turn an angle to the right and run in an Easterly direction for a distance of 737.39 feet, more or less, to the point of beginning, containing 3.4 acres, more or less.
