Come now George E. Wilson, the elder son of John Wilson, and  
Lillian Dobbs, a disinterested party, who state that they  
have personal knowledge of the following facts, and to acknowledge that  
the same are true and correct, to the best of their knowledge and in-  
formation:

1. That John Wilson was married to Savannah G. Wilson on of about  
June 15, 1906, in Shelby County, Alabama, and five (5) children  
were born as the result of said marriage, to-wit: George E. Wilson,  
Fred J. Wilson, James B. Wilson, Andrew C. Wilson and John Wilson, Jr.,  
who died intestate in Hennipen County, Minnesota on or about April 27,  
1975, said John Wilson, Jr. being survived by his widow, Deanna F.  
Wilson, and his two children, Michael D. Wilson and Deanna L. Wilson,
