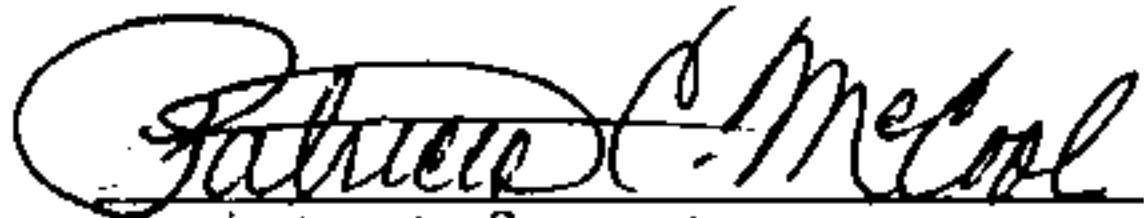

135, in the Probate Office of Shelby County, Alabama.

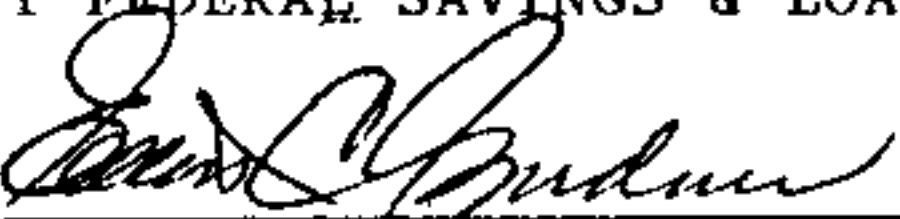
But it is expressly understood and agreed that this release

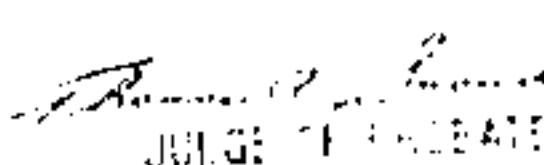

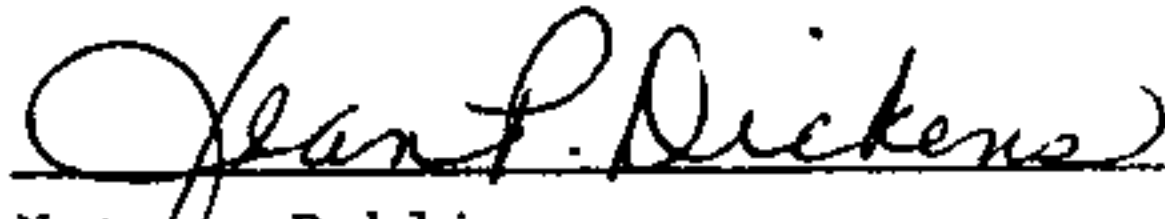
