

PARTIAL RELEASE OF MORTGAGE

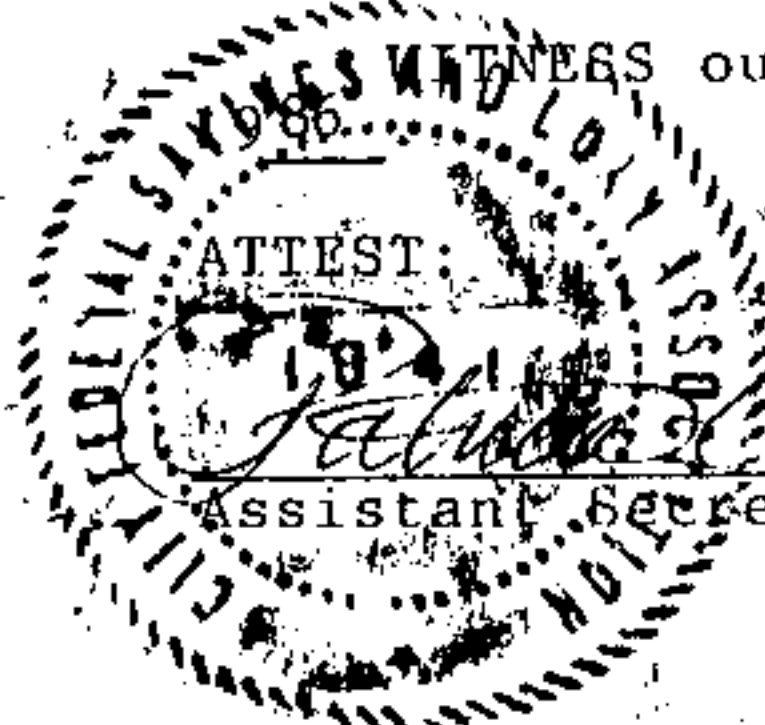

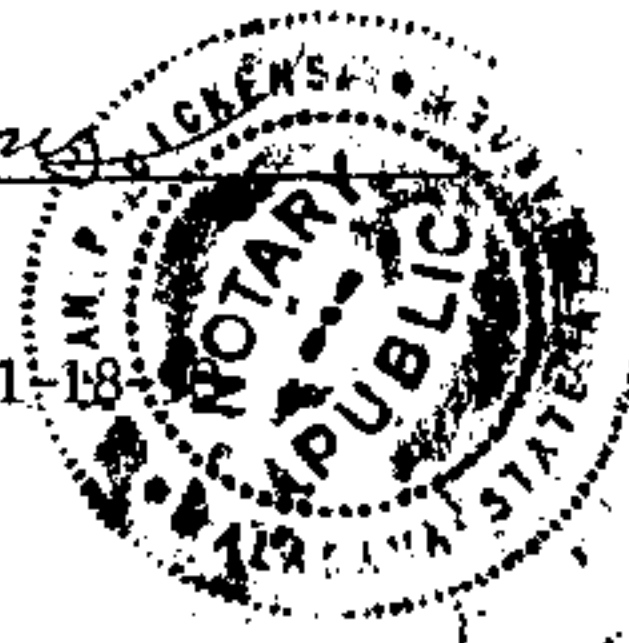
