I hereby authorize and empower the Executor acting hereunder to sell at public or private sale and by proper instrument convey, without order of Court, any or all of the property belonging to my estate at such price and upon such terms and conditions as he may deem best, if and when such a sale shall be deemed necessary or for the best interests of my estate or the beneficiary thereof.

In the event in the discretion of my executor it shall be necessary or desirable, my Executor is authorized and empowered to borrow funds for the purpose of paying debts, charges and taxes against my estate and as security to mortgage or pledge any property he deems best.

I have executed this my Last Will on this 9<sup>th</sup> day of December, 1976, and have asked the witnesses attesting same to do so in my presence, in the presence of each other, and it in their presence.
