**Certificate of Judgment**

I, JAMES E. VANDEGRIFT, Clerk of the United States District Court for the Northern District of Alabama, do hereby certify that on the eighteenth day of December, 1985, a Consent Judgment was rendered by said Court in the above-styled cause wherein UNITED STATES OF AMERICA obtained a judgment against RICHARD W. BELL whose address is 1970 Chandaway Drive, Pelham, Alabama 35124, as shown in the Court proceeding for the sum of TWENTY FOUR THOUSAND AND 00/100 (\$24,000.00) DOLLARS. The plaintiff will have and recover of Defendant interest on the judgment at the rate of 9.50 percent from the date of judgment until paid; and that the Defendant will satisfy this judgment by making twelve (12) consecutive monthly payments of THREE HUNDRED AND 00/100 (\$300.00) DOLLARS each commencing August 1, 1985, with proportional increases thereafter based upon defendant's assets and income. The monthly payments are due on or before the first day of each month; and that in the event any monthly installment as specified in paragraph 2 above is in default ten days of more, a late charge of five percent of the amount of such scheduled payment shall be added to the outstanding balance. If the default is not cured within twenty days, the Plaintiff shall have the following options:

(1) to accelerate the total remaining outstanding balance and to declare said balance immediately due and payable, with interest at the rate of eighteen percent per annum on the unpaid balance together with costs and reasonable attorneys fees, or

(2) to add one and one-half percent interest per month on the outstanding unpaid balance.
