A part of the Northwest Quarter of the Northwest Quarter of Section 27, Township 19 South, Range 2 West, Shelby County, Alabama, being more particularly described as follows: Begin at the Northwest corner of the Northwest Quarter of the Northwest Quarter of said Section and run East along the North line of said Section 665.46 feet; thence right 88 degrees 42 minutes 30 seconds and run South 281.60 feet; thence left 33 degrees 53 minutes 00 seconds and run Southeasterly 248.28 feet to the Northwesterly right of way of Cahaba Valley Road; thence right 90 degrees 00 minutes 00 seconds and run Southwesterly along Cahaba Valley Road 38.3 feet to the point of curve to the right (said curve having a central angle of 10 degrees 39 minutes 09 seconds and a radius of 2785.0 feet); thence run along the arc of said curve in a Southwesterly direction 517.80 feet; thence an angle right of 78 degrees 34 minutes 00 seconds to tangent and run Northwesterly 418.90 feet; thence left 98 degrees 27 minutes 00 seconds and run Southwesterly 105.00 feet to a point on the West line of said Quarter-Quarter section; thence right 132 degrees 48 minutes 00 seconds and run North along said West line 498.4 feet to the point of beginning.
