I

II

The nature of the business of the corporation and the objects and purposes for which the corporation is formed are:

(a) To transact a general real estate agency, buying and selling and dealing in real estate and real property, and renting and managing real estate.

(b) To subscribe for, buy, sell and own capital stock and notes and bonds in any other corporation, and to exercise the rights, privileges and powers or ownership there-

(c) To do and perform generally all acts ordinarily or customarily done or performed in connection with or reasonably incident to the business of those engaged in like or similar business, and to engage in any other business now or hereafter permitted by the laws of the State of Alabama to corporations of a like or similar nature.

(d) To construct, purchase, sell, own, mortgage, pledge, lease, assign or otherwise dispose of or invest in, trade in, or deal in any form of real property and personal property of every class and description.

(e) To take, buy, exchange, lease or otherwise acquire real estate and any interest or right therin, and to hold, own, operate, control, maintain, manage and develop the same and to construct, maintain, alter, manage and control directly or through ownership of stock in any other corporation any and all kinds of buildings, stores, offices, warehouses, mills, shops, factories, machinery and plants, and any and all other structures and erections which may at any time be necessary, useful or advantageous for the purpose of this corporation.

(f) To sell, assign and transfer, convey, lease or otherwise alienate or dispose of, and to mortgage or otherwise encumber the lands, buildings, real and personal property of the corporation wherever situated and any and all legal and equitable interests therein.




