releases, quitclaims, grants, sells, and conveys to Lizzie Peeples, Irene Davis,

(hereinafter called Grantee), all our right, title, interest, and claim in or to the following described real

estate, situated in Shelby County, Alabama, to-wit:

An undivided two-fifths (2/5) interest, to Goldie Mae Reese;
