- (c) To acquire, and pay for in cash, stocks or bends of this corporation or otherwise, the good-will, right, assets and property and to undertake or assume the whole or any part of the obligations or liabilities of any person, firm, association of corporation.
- (d) To manufacture, purchase or otherwise acquire, own, mortgage, pledge, sell, assign, transfer, or otherwise dispose of, to invest, brade,

deal in and deal with real and personal property of every class and description.

- (e) To guarantee, purchase, hold, sell, assign, transfer, mortgage, pledge, or otherwise dispose of, the shares of the capital stock of, or any bonds, securities or evidence of indebtedness created by any other corporation or corporations organized under the laws of this state or any other state, county, nation or government, and while the owner thereof to exercise all the rights, powers and privileges of ownership.
