JUDGMENT

This cause came on to be heard, both parties having announced ready for trial. Both parties were present in open court represented by their respective attorneys of record and made it known to the Court that a settlement had been reached between the parties. Based thereon, the Court is of the opinion that the following judgment should be entered. It is, therefore,

ORDERED and ADJUDGED by the Court as follows:

1. That judgment by consent is entered in favor of the Plaintiff and against the Defendant in the sum of Twelve Thousand Nine Hundred Dollars (\$12,900.00) on Count 1 of Plaintiff's complaint.

2. That Count 2 of Plaintiff's complaint is dismissed with prejudice.

3. That this judgment is in derogation of and enforcement of, and is one and the same as, that certain judgment entered against the Defendant in the Circuit Court of Jefferson County, Alabama in an action styled BeBe M. Morgan, Plaintiff, vs. Robert W. Morgan, Defendant, being case number DR 82 500-592 WCZ, in paragraph 12 of the agreement of the parties incorporated in the final judgment of divorce entered therein.

4. The costs of court accrued herein are hereby taxed against the Defendant, for the collection of which let execution issue.
