to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we,

 (herein referred to as grantors) do grant, bargain, sell and convey unto

HEYWARD L. MEADOWS and wife, BETTY MEADOWS,
 (herein referred to as GRANTEES) as joint tenants, with right of survivorship, the following described real estate situated in

Shelby County, Alabama to-wit:

See Exhibit "A" for legal description of real property conveyed by this Warranty Deed LESS AND EXCEPT title to minerals underlying this real property with mining rights and privileges belonging thereto as reserved by instrument recorded in Deed Book 145, at Page 165, in the Office of the Judge of Probate of Shelby County, Alabama, and subject to rights acquired by Alabama Power Company by instrument recorded in Deed Book 242, at Page 369, in said Probate Records.

Subject to taxes for 1986 that are a lien, but not due and payable until October 1, 1986, which taxes Grantor agrees to pay. Grantees agree to assess taxes on this real property for 1987 and subsequent years.

Subject to all planning, zoning, health and other governmental regulations affecting subject real property.

Subject to all rights-of-way, easements and transmission lines, if any, in evidence through use.

Subject to all rights-of-way, easements, limitations and restrictions shown on the survey map or plat specified in Exhibit "A" to this Warranty Deed, a copy of which map was delivered to Grantees either on this date or prior hereto.

Ricky Wayne Seale is one and the same person as the Grantee designated as Rick Seale in that certain deed from Gulf States Paper Corporation conveying acreage in the NW 1/4 of Section 35, Township 24 North, Range 15 East, Shelby County, Alabama, of which the above described real property is a part.

The above described real property does not constitute any part of the homestead of the Grantor Ricky Wayne Seale, who resides with his wife Sharon Seale at 2320 Ricky Ridge Road, Birmingham, Alabama 35216.

TO HAVE AND TO HOLD Unto the said GRANTEES as joint tenants, with right of survivorship, their heirs and assigns, forever; it being the intention of the parties to this conveyance, that (unless the joint tenancy hereby created is severed or terminated during the joint lives of the grantees herein) in the event one grantee herein survives the other, the entire interest in fee simple shall pass to the surviving grantee, and if one does not survive the other, then the heirs and assigns of the grantees herein shall take as tenants in common.

And I (we) do for myself (ourselves) and for my (our) heirs, executors, and administrators covenant with the said GRANTEES, their heirs and assigns, that I am (we are) lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise noted above; that I (we) have a good right to sell and convey the same as aforesaid; that I (we) will and my (our) heirs, executors and administrators shall warrant and defend the same to the said GRANTEES, their heirs and assigns forever, against the lawful claims of all persons. There is no warranty or representation as to the condition or quality or quantity of this real property.

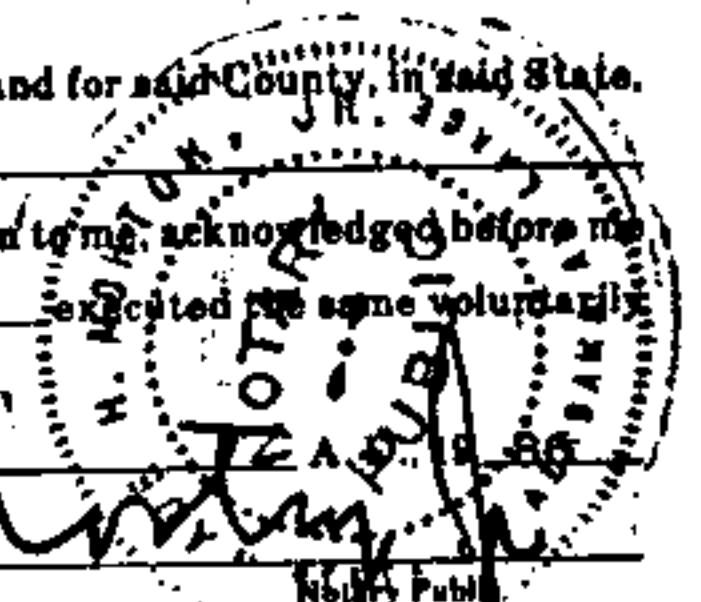

Commence at the Northwest corner of Section 35, T.S. 24N, R.15E, Shelby County, Alabama and run thence East along the North line of said Section 35 a distance of 2008.83' to a point, Thence South a distance of 1311.57' to the "POINT OF BEGINNING" and being on the South Bank of Shack Branch Cove on Lay lake, Thence South 81°-59'-32" East along said South Bank a distance of 50.27' to a point, Thence South 53°-35'-34" East continuing along said South Bank a distance of 17.34' to a point, Thence South 27°-16'-12" East continuing along said South Bank a distance of 34.13' to a point, Thence South 18°-53'-52" West a distance of 219.56' to a point on the North right-of-way line of a 60' wide County Gravel Road, Thence North 83°-20'-16" West along said right-of-way line a distance of 71.28' to the P.C. of a curve to the right having a Central angle of 9°-55'-29" a radius of 166.82' and a chord bearing North 78°-22'-35" West 28.85' to a point, Thence North 20°-37'-18" East a distance of 257.79' to the "POINT OF BEGINNING", containing 0.54 acre.

Commence at the Northwest corner of Section 35, T.S. 24N, R.15E, Shelby County, Alabama and run thence East along the North line of said Section 35 a distance of 1906.58' to a point, Thence South a distance of 1324.06' to the "POINT OF BEGINNING" and being on the South Bank of Shack Branch Cove on Lay Lake, Thence North 65°-20'-46" East along said South Bank a distance of 51.09' to a point, Thence South 81°-00'-49" East along said South Bank a distance of 56.51' to a point, Thence South 20°-37'-18" West a distance of 257.79' to a point on the North right-of-way line of a 60' wide County Gravel Road, Thence along a curve to the right having a Central angle of 7°-24'-36" a radius of 166.82' and a chord bearing North 69°-42'-34" West, 21.56' to the P.T. of said curve, Thence North 66°-00'-16" West continuing along said right-of-way line a distance of 78.40' to a point, Thence North 22°-59'-44" East a distance of 205.78' to the "POINT OF BEGINNING", containing 0.52 acre.
