5-5-86 By agreement of the parties, and with leave of court, the following judgments are due to be and hereby rendered:

- (1) In favor of plaintiff and against Car City of Jasper, Inc. and its individual guarantors, Tuscaloosa Enterprises, Inc., Garve Ivey Sr., Gary Miller Ivey, and Garve Ivey, Jr., in the amount of Six Hundred, Forty-Eight Thousand, Seven Hundred Three and 66/100 Dollars (648,703.66).
- (2) In favor of plaintiff and against defendant, First Mark Leasing Corporation, and its guarantors, Gary Miller Ivey and Garve Ivey, Jr., in the amount of One Hundred, Eighty-One Thousand, Seven and 37/100 dollars (181,007.37)
- (3) In favor of plaintiff and against Car City of Graysville, Inc. in the amount of Fifteen Thousand Six Hundred, Thirteen and 96/100 Dollars (15,613.96)/
- (4) In favor of plaintiff and against defendant, Tuscaloosa Enterprises, Inc., in the amount of Seventy-Five Thousand, Seven Hundred, Four and 99/100 Dollars (75,704.99).
- (5) In favor of plaintiff and against defendant, Garve Ivey, Sr. individually, in the amount of Nineteen Thousand, Seven Hundred, Fifty-Nine and 58/100 Dollars (19,759.58).
- (6) In favor of plaintiff and against defendant, Gary Miller Ivey, individually, in the amount of Nine Thousand, One Hundred, Eighty-Five and 20/100 Dollars (9,185.20).

Each of the above judgments is a separate judgment. All costs are taxed to the defendants.
