to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we,

SIMONE J. AMATO and wife, LESLIE AMATO
(herein referred to as grantors) do grant, bargain, sell and convey unto

THOMAS E. SMITH and ESTHER D. SMITH
(herein referred to as GRANTEES) as joint tenants, with right of survivorship, the following described real estate situated in
Shelby _____ County, Alabama to-wit:

A part of the SW 1/4 of the SW 1/4 of Section 33, Township 20 South, Range 3 West, and the NW 1/4 of the NW 1/4 of Section 4, Township 20 South, Range 3 West, Shelby County, Alabama, described as follows: Commence at the SW corner of the SW 1/4 of the SW 1/4 of Section 33 and run East along the East line of said 1/4-1/4 Section 435.0 feet to the point of beginning; thence North and parallel to the West line of said 1/4-1/4 Section to a point of intersection with the South line of Shelby County Road No. 266; thence Northeasterly along said South right of way line to a point of intersection with a line which is 675.0 feet East of and parallel to the West line of said 1/4-1/4 Section; thence South to a point of intersection with the South line of the NW 1/4 of the NW 1/4 of Section 4, Township 21 South, Range 3 West; said point being 675.0 feet East of the SW corner of the NW 1/4 of the NW 1/4 of said Section 4; thence West along said South line 240.0 feet; thence North and parallel to the West line of said 1/4-1/4 Section to a point of beginning; being situated in Shelby County, Alabama.

Subject to easements and restrictions of record, and current state, county and city taxes.

Subject to that certain mortgage of Simone J. Amato to Federal Land Bank of New Orleans recorded in Mortgage Book 355, page 685, which grantor covenants and agrees to pay in accord with all its terms, and upon full payment of the purchase money mortgage given as a part of the consideration for this conveyance, grantor warrants that he will pay all sums necessary to secure the release of the subject property from that mortgage.

TO HAVE AND TO HOLD Unto the said GRANTEES as joint tenants, with right of survivorship, their heirs and assigns, forever; it being the intention of the parties to this conveyance, that (unless the joint tenancy hereby created is severed or terminated during the joint lives of the grantees herein) in the event one grantee herein survives the other, the entire interest in fee simple shall pass to the surviving grantee, and if one does not survive the other, then the heirs and assigns of the grantees herein shall take as tenants in common.

And I (we) do for myself (ourselves) and for my (our) heirs, executors, and administrators covenant with the said GRANTEES, their heirs and assigns, that I am (we are) lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise noted above; that I (we) have a good right to sell and convey the same as aforesaid; that I (we) will and my (our) heirs, executors and administrators shall warrant and defend the same to the said GRANTEES, their heirs and assigns forever, against the lawful claims of all persons.
