2-20-86 Judgment by consent in favor of the plaintiffs, Robert L. Ragsdale and Betty S. Ragsdale and against the defendants, George Johnston, III and Donald R. Powell in the amount of \$65,000.00, to be paid by defendants, Johnston and Powell to the plaintiffs as follows:

- (1) The first payment shall be in the sum of \$25,000.00 and shall be paid within 90 days of the entry of judgment;
- (2) The second payment shall be in the sum of \$20,000.00 and shall be paid within 180 days of the entry of judgment.
- (3) The third payment shall be in the sum of \$20,000.00 and shall be paid within 365 day of the entry of judgment.

Interest shall accrue on the entire judgment at the rate of 12 per cent per annum and shall be paid 365 days after entry of judgment.

If any payment is not made when and as due, the entire amount of the judgment plus interest shall immediately become due and payable. Execution may issue without notice upon the failure of defendants to meet and make any payment when and as due.

This consent judgment is in full settlement of all claims of plaintiffs against defendants, Johnston and Powell and all claims of defendants Johnston & Powell against plaintiffs. Costs to be taxed against defendants, Johnston and Powell.
