Commence at the northwest corner of the NE $\frac{1}{4}$ of SE $\frac{1}{4}$ Sec 25, Twp 21 South, Range 1 West, thence proceed South 89 deg 03 min 30 sec West (MB) along the north boundary of NW $\frac{1}{4}$ of SE $\frac{1}{4}$ and NE $\frac{1}{4}$ of SW $\frac{1}{4}$ sec 25, Twp 21 South, Range 1 West, for a distance of 2285.43 feet to a point on the west right of way line of Washington Street; thence turn an angle of 100 deg 18 min to the left and proceed south 11 deg 14 min 30 sec east (MB) along the said west ROW line of Washington Street; a distance of 1295.51 feet to the point of intersection with the South right of way line of Bolton Lane thence turn an angle of 100 deg. 18 min to the right and proceed South 89 deg 03 min 30 sec West (MB) along the said right of way line of Bolton Lane, a distance of 1011.95 feet to the point of beginning of the lot herein described (being along the NW corner of J.L. Ray lot) thence turn an angle of 90 deg 00 min to the left and proceed along the West boundary of the J. L. 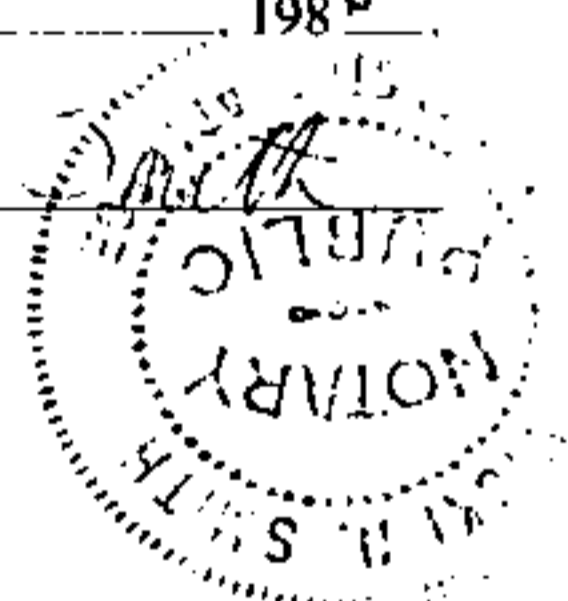
