The undersigned property owners, UNITED STATES PIPE AND FOUNDRY COMPANY (U. S. Pipe), EMORY REALTY, INC. (Emory), and THE WATER WORKS BOARD OF THE CITY OF BIRMINGHAM (the Board), being the owners of all of the real property described in Exhibit A hereto, hereby petition the City Council of the City of Birmingham, Alabama, to annex to said City of Birmingham, a municipal corporation, by rearranging and extending the boundaries of the said municipal corporation to include said property, which is contiguous to the corporate limits of said municipal corporation, and which is described in said Exhibit A hereto, and shown on the map attached hereto as Exhibit B, which shows the relationship of the property proposed to be annexed to the corporate limits of the said municipal corporation.

This petition is conditioned upon Emory and the Board, jointly or severally, acquiring the entire interest of U. S. Pipe in said property on or before February 1, 1987, and in the event Emory and the Board, jointly or severally, do not so acquire the entire interest in said property, then this petition and any ordinance or resolution of said City of Birmingham assenting to this petition or the annexation of said property or annexing said property or rearranging the boundaries of said City of Birmingham to include said property shall be null and void and of no further force and effect.

~~This petition is further conditioned upon the granting by the governing body of the City of Birmingham of a fifteen-year tax exemption as provided for in Sections 2, 3, and 4 of Act No. 787 of the 1977 Alabama Legislature (Acts 1977, pp. 1357-1358) with respect to the territory to be annexed. This petition shall be considered the said property owner's petition for such tax exemption.~~

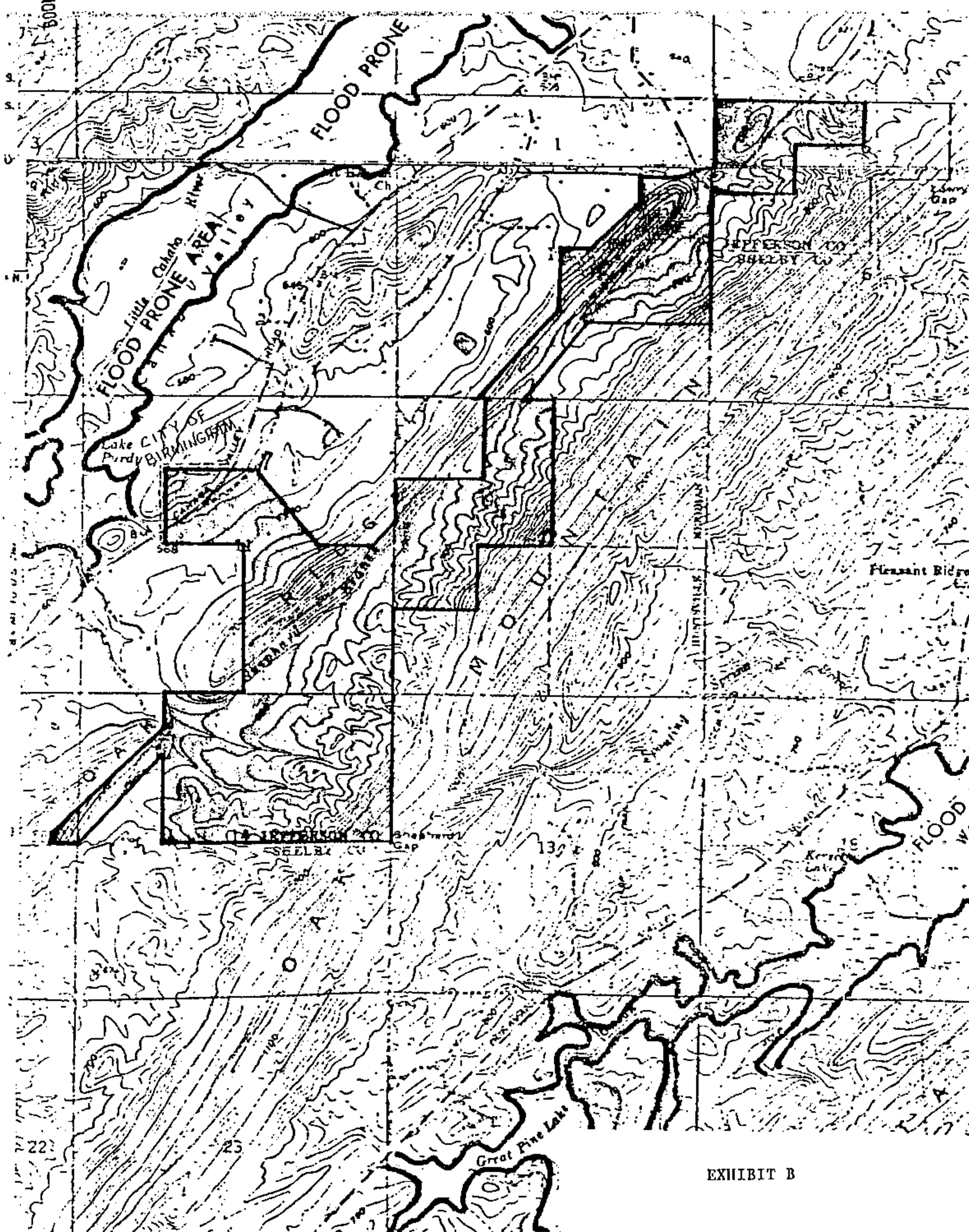
