

Articles of Incorporation
of the
CAHABA VALLEY RETRIEVER CLUB, INC.

ARTICLE I
Name and Purpose

Section 1. Name. This Club is organized as a non-profit corporation and shall be known as the Cahaba Valley Retriever Club, Inc.

Section 2. Duration. The duration of the corporation is not limited.

Section 3. Purpose. The objectives of the Club shall be:

- (a) To educate handlers, hunters, owners and the general public through the encouragement and promotion of quality breeding, training and field testing of purebred hunting retrievers in order to bring forth and perpetuate their natural hunting and retrieving abilities.
- (b) To do all in its power to protect and advance the interests of hunting retrievers through education and the encouragement of sportsman-like participation in field tests and retriever training.
- (c) To properly educate handlers, hunters, owners and the general public in the utilization and training of retrievers.
- (d) To conduct training field tests as well as sanctioned and licensed field tests for the hunting retriever.
- (e) To promote use of the hunting retriever as a conservation tool for the proper management of all of our wildlife resources.
- (f) To devote all profits accruing to the Club to the above purposes or to make specific bequests to such charitable or civic organizations as shall be approved by a majority vote of those in attendance and voting at a Club meeting; and under no circumstances to pay a salary, fee, commission or dividend to any member or to have or issue shares of stock.

Section 4. The members of the Club shall adopt and may from time to time revise the Club by-laws as may be required to carry out these objectives.

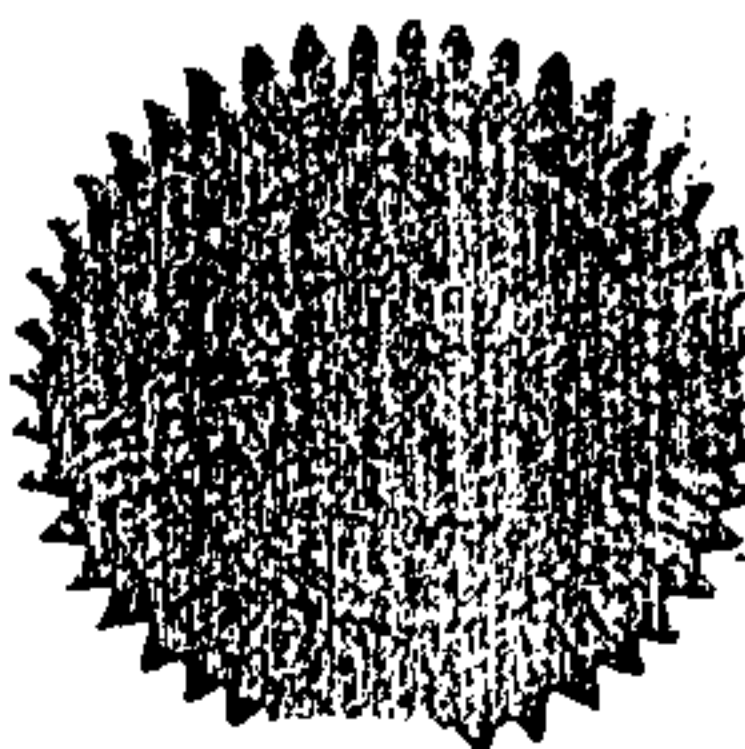
