ASSIGNMENT OF PURCHASE MONEY NOTE,

Note, the Mortgage and the Financing Statement.

hereby acknowledged, Assignor does hereby transfer, assign,
set over and convey, without recourse, to Assignee all of
Assignor's right, title and interest in and to the Note, the
Mortgage and the Financing Statement.
