ORDINANCE NO. 86- 170

AN ORDINANCE TO ALTER, REARRANGE AND EXTEND THE CORPORATE LIMITS OF THE CITY OF BIRMINGHAM, ALABAMA, SO AS TO EMBRACE AND INCLUDE WITHIN THE CORPORATE AREA OF SAID CITY ALL TERRITORY NOW WITHIN SUCH CORPORATE LIMITS AND ALSO CERTAIN OTHER TERRITORY CONTIGUOUS TO SAID CITY.

WHEREAS, certain petitions signed by The Water Works Board of the City of Birmingham seeking annexation into the City of Birmingham of that certain territory therein described, together with a map of said territory showing its relationship to the corporate limits of the City has been filed with the City Clerk of the City of Birmingham; and,

WHEREAS, this Council, after public hearing held pursuant to notice published under the provisions of Section 4 of Act No. 32 of the 1964 First Extraordinary Session of the Legislature of Alabama, has determined and found that the matters set forth and alleged in said petition are true, and that it is in the public interest that said property be annexed to the City of Birmingham;

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Birmingham as follows:

Section 1. That said Council hereby annex said territory to the City of Birmingham, Alabama, the corporate limits of the City to be extended and rearranged pursuant to the provisions of the aforesaid Act No. 32, more particularly described as follows:

The following property situated in Jefferson County and Shelby County, Alabama:

BEGIN AT THE SOUTHEAST CORNER OF SECTION 26, TOWNSHIP 18 SOUTH, RANGE 2 WEST, THENCE WEST TO THE SOUTHWEST CORNER OF SOUTHWEST 1/4 OF SOUTHEAST 1/4; THENCE NORTH TO SOUTH RIGHT-OF-WAY OF FLORIDA SHORT ROUTE (OLD HIGHWAY 91); THENCE NORTHEAST ALONG SAID RIGHT-OF-WAY TO INTERSECTION OF NEW HIGHWAY 280; THENCE NORTHWEST TO NORTHEAST RIGHT-OF-WAY OF NEW HIGHWAY 280; THENCE NORTHWEST ALONG SAID RIGHT-OF-WAY TO WEST LINE OF SAID SECTION 26; THENCE NORTH TO NORTHWEST CORNER OF SOUTHWEST 1/4 OF NORTHWEST 1/4; THENCE EAST TO NORTHEAST CORNER OF SAID 1/4-1/4; THENCE NORTH TO SOUTH RIGHT-OF-WAY OF LAKESIDE DRIVE; THENCE NORTHEAST ALONG SAID RIGHT-OF-WAY TO NORTH LINE OF SAID SECTION 26; THENCE EAST TO NORTHEAST CORNER OF NORTHEAST 1/4 OF NORTHWEST 1/4; THENCE NORTH IN SECTION 23 TO NORTHWEST CORNER OF NORTHWEST 1/4 OF SOUTHEAST 1/4 OF SECTION 23, TOWNSHIP 18 SOUTH, RANGE 2 WEST; THENCE EAST TO NORTHEAST CORNER OF SAID 1/4-1/4; THENCE NORTH TO NORTHWEST CORNER OF SOUTHEAST 1/4 OF NORTHEAST 1/4 OF SAID SECTION 23; THENCE EAST TO NORTHEAST CORNER OF SAID 1/4-1/4; THENCE SOUTH TO SOUTHEAST CORNER OF SAID 1/4-1/4; THENCE EAST IN SECTION 24 TO NORTHEAST CORNER OF NORTHWEST 1/4 OF SOUTHWEST 1/4; THENCE SOUTH TO SOUTHEAST CORNER OF SAID 1/4-1/4; THENCE EAST TO NORTHEAST CORNER OF SOUTHWEST 1/4 OF SOUTHEAST 1/4 OF SECTION 24, TOWNSHIP 18 SOUTH, RANGE 2 WEST; THENCE SOUTH TO SOUTHEAST CORNER OF SAID 1/4-1/4; THENCE WEST ALONG SOUTH LINE OF SECTION 24 TO SOUTHWEST CORNER OF SOUTHWEST 1/4 OF SOUTHEAST 1/4; THENCE SOUTH IN SECTION 25 TO SOUTHWEST CORNER OF NORTHWEST 1/4 OF NORTHEAST 1/4 OF SECTION 25, TOWNSHIP 18 SOUTH, RANGE 2 WEST; THENCE EAST TO SOUTHEAST CORNER OF SAID 1/4-1/4; THENCE SOUTH TO SOUTHEAST CORNER OF NORTHWEST 1/4 OF SOUTHEAST 1/4; THENCE WEST TO SOUTHWEST CORNER OF SAID 1/4-1/4; THENCE SOUTH TO SOUTHEAST CORNER OF SOUTHEAST 1/4 OF SOUTHWEST 1/4 OF SAID SECTION 25; THENCE WEST TO SOUTHWEST CORNER OF SAID 1/4-1/4; THENCE NORTH TO NORTHWEST CORNER OF SAID 1/4-1/4; THENCE WEST TO NORTHWEST CORNER OF SOUTHWEST 1/4 OF SOUTHWEST 1/4 OF SECTION 25; THENCE SOUTH TO SOUTHWEST CORNER OF SECTION 25, TOWNSHIP 18 SOUTH, RANGE 2 WEST AND SOUTHEAST CORNER OF SECTION 26 AND POINT OF BEGINNING.

LESS AND EXCEPT THE SOUTHEAST 1/4 OF SOUTHEAST 1/4 AND NORTHEAST 1/4 OF SOUTHEAST 1/4 OF SECTION 23, TOWNSHIP 18 SOUTH, RANGE 2 WEST AND THE SOUTHEAST 1/4 OF NORTHWEST 1/4 OF SECTION 25, TOWNSHIP 18 SOUTH, RANGE 2 WEST.

CONNECTED TO THE CITY OF BIRMINGHAM VIA SICARD HOLLOW ROAD (FROM NORTHWEST 1/4 OF NORTHWEST 1/4 SECTION 24 TOWNSHIP 18 SOUTH, RANGE 2 WEST TO NORTHEAST 1/4 OF NORTHWEST 1/4 SECTION 19, TOWNSHIP 18 SOUTH, RANGE 1 WEST).

Section 2. The City of Birmingham hereby agrees to comply with those provisions of Act No. 604 enacted at the 1976 Regular Session of the Legislature of Alabama pertaining to the assumption and payment of an annexed fire district's debt or the payment to said fire district of an amount equal to six times the amount of dues that the portion of said fire district being annexed paid to said fire district during the preceding year.

Section 3. That the City Clerk shall file a certified copy of this ordinance containing an accurate description of said annexed territory with the Probate Judges of Jefferson County, Alabama, and Shelby County, Alabama, also cause a copy of this ordinance to be published in a newspaper of general circulation in the City of Birmingham.

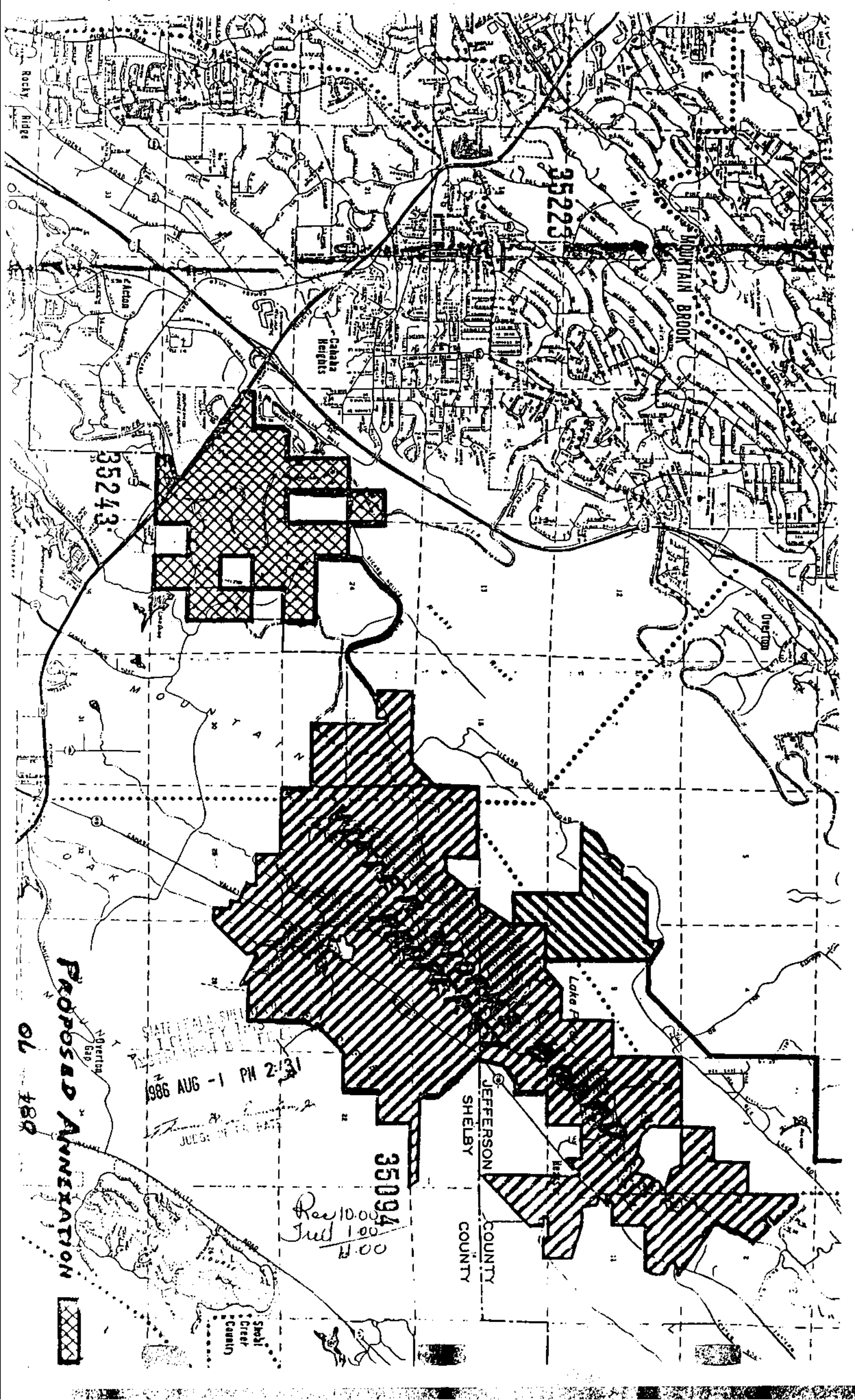
