14, Township 20 South, Range 3 West lying West of Buck Creek.

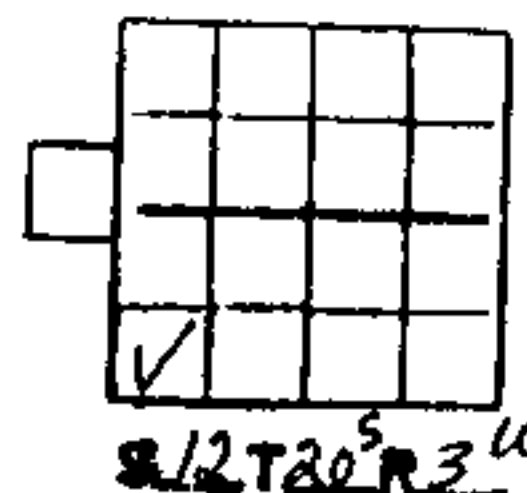
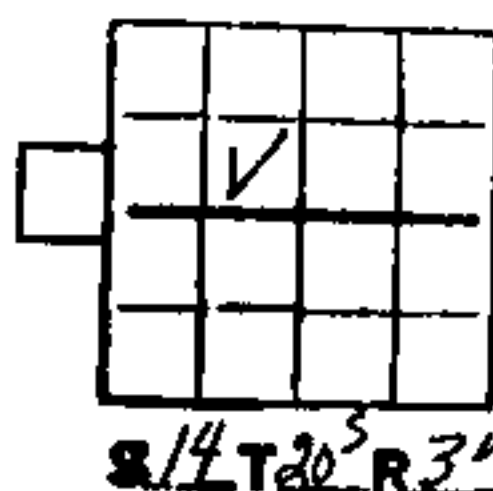
